

## Activities

During the academic year 2017/2018, ISSBS Celje will perform:

- **Seminars for pupils/students** at all levels of education: elementary (12–14 years), secondary and tertiary level;
- **Seminars for teachers** at elementary and secondary schools, as well as at higher education institutions;
- **Conferences for school managers** at elementary and secondary schools, as well as at higher education institutions;
- **A final conference** for teachers, school management, policy makers, researchers, managers in financial institutions and other practitioners in the field.

Lecturers at seminars and conferences will be academics from ISSBS, practitioners from schools, experts from Slovenian financial institutions and some guest lecturers from abroad (whose lectures/presentations will be in English).

The research will be designed with the purpose of highlighting good practices in school curricula at different levels, as well as of enhancing teaching on EU integration and financial literacy in schools.

- Students' opinions and debates about EU topics;

## EU Integration and Financial Education (€U-InFed)

The project €U-InFed is co-funded by the EC in the framework of the Jean Monnet program and it focuses on EU facts and figures of EU integration and financial education. Discussion on EU integration (including on EU monetary policies) is key in the current crisis affecting both EU and accession countries. Like never before, researchers, public authorities, community groups, industry associations and international organizations are developing financial education initiatives, as a main element in the creation of informed and responsible EU citizens. The aim of the project is to deepen the understanding of EU integration, as well as of financial education, among different target groups (also the importance and role of crypto currencies, such as bitcoin).
